A. District II Staff Update

- The Alamo Liaison meeting for June has been cancelled because of scheduling conflicts.
- Supervisor Andersen would like the Alamo MAC to conduct the next AOB meeting, set for June 19, 2013. *MAC involvement postponed until August 2013 AOB meeting, due to lack of MAC quorum for the June AOB meeting.*
